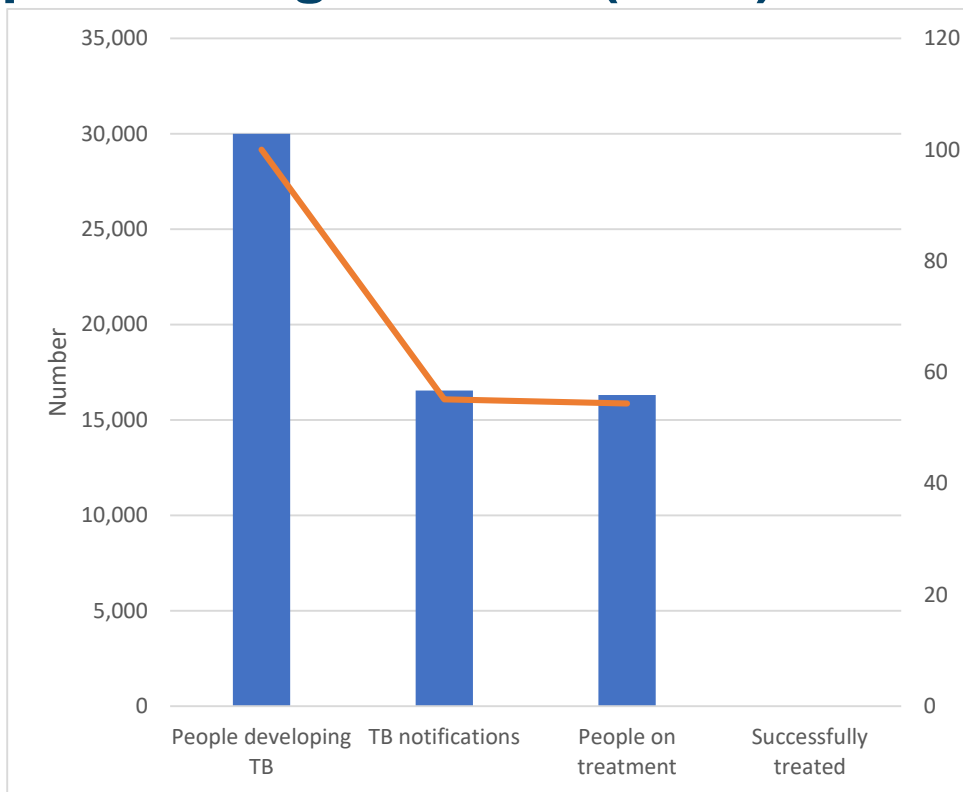

**Timeline:** December 2021 - December 2022

### Objectives

- To conduct needs and feasibility assessment for raising awareness about CRG in TB and to determine the best approach to CLM in Zimbabwe.
- To adapt and develop the OneImpact CLM platform for the Zimbabwean context.
- To train stakeholders (TB Survivors, First Responders, Advocates and NTP) on adapted OneImpact Platform.
- To launch OneImpact CLM in Gweru, Midlands Province, Zimbabwe.
- To collect, analyse and produce OneImpact CLM reports to inform effective communication.
- To ensure CLM data utilization at individual, community and programmatic levels for advocacy and action.
- To provide feedback to affected communities regarding impact of their input (close the feedback loop).
- To monitor and evaluate the OneImpact CLM intervention.
- To plan for the scale up of OneImpact CLM.
- To strengthen evidence-based advocacy.
- To participate and engage in TB advocacy and accountability initiatives at national, regional, and global levels.

## Students and Youth Working on Reproductive Health Action Team

**Project Location:** 10 Province

**Timeline:** January 2022 - January 2023

### Objectives

- To build the capacity of college health workers on youth centered, rights-based integrated TB&HIV care and support in 10 State Universities in each of the 10 provinces of Zimbabwe.
- To raise awareness about TB, mental health and the rights-based approach in the context of TB&HIV among students living with HIV in Zimbabwe's Higher Education Sector
- To advocate for TB quality care and support services that are free from stigma and discrimination in college health facilities for students living with HIV.
- To conduct community-led monitoring of youth centered, rights-based integrated TB and HIV services in 10 universities in each of the 10 provinces of Zimbabwe.
- To participate and engage in TB advocacy and accountability initiatives at national, regional, and global levels.

## Grantees

### Disaster and Environmental Management Trust

**Proposal location:** Mutoko and Mudzi rural districts in Zimbabwe

**Timeline:**

**Overall aim:**

- To enhance access to TB services for priority groups in Zimbabwe through meaningful community and private sector engagement which will result in early identification of cases, early diagnosis and linkage to adequate care and treatment, ultimately contributing towards closing the 28% TB notification gap in Zimbabwe.

**Proposal Objectives:**

- To facilitate access to TB screening services, patient centered diagnosis and treatment for priority groups in Mutoko and Mudzi districts of Zimbabwe and bring TB services to where people live.
- To promote the institutionalization of routine TB screening in formal mining companies in Mutoko and Mudzi districts of Zimbabwe and capacitate mine workers on how to claim their workplace rights enshrined in the constitution and the Zimbabwe Workplace Policy on HIV and Aids, TB, and other Opportunistic illnesses.
- To raise awareness of TB and generate demand for TB screening services among priority groups such as artisanal miners, sex workers, people living with HIV, the elderly, people who inject drugs and ethnic minorities in Mutoko and Mudzi districts of Zimbabwe.

### **Aim:**

- To ensure meaningful youth participation in integrated TB and HIV services provision including their participation in the review of TB and HIV related policies and programs.

### **Objectives:**

- To coordinate the effective participation of young people at district, provincial and national level TB and HIV review and coordination mechanisms in the 10 provinces of Zimbabwe
- To expand the involvement of young people in community led monitoring on young people's access to TB and HIV services in the 10 provinces of Zimbabwe
- To increase government accountability on the delivery of integrated TB and HIV services for young people at 10 health centres in Zimbabwe
- To participate and engage in TB advocacy and accountability initiatives at national, regional, and global levels

- To finalize the CRG Assessment and costed action plan for Zimbabwe for inclusion in the GF GC7 Fund request by May 2023,
- To coordinate country TB response efforts and strengthen partnerships and collaboration for faster progress towards UNHLM targets and ending TB in Zimbabwe by 2023.
- To participate and engage in TB advocacy and accountability initiatives at national, regional, and global levels by December 2023.

**Timelines:** Nov 2022-May 2024

**Overall aim:**

- To strengthen domestic resource mobilisation mechanisms at country level.

**Objectives:**

- To enhance domestic resource mobilization and increase funding for TB
- To generate high-level advocacy activities targeting country key stakeholders and decision-makers to ensure alignment of national and global advocacy efforts
- To conduct strong TB advocacy and create a critical mass to deliver change around TB issues.
- To position the country- level platforms as a strategic leaders and key conveners and facilitators on TB.
